**MITIGATION PLAN FOR FOUR NEW JERSEY COUNTIES
DOWNE TOWNSHIP, CUMBERLAND COUNTY, NEW JERSEY**

A Resolution of the Downe Township Committee adopting the Mitigation Plan for Four New Jersey counties.

WHEREAS, the Downe Township Committee recognized the threat that natural hazards pose to people and property within Downe Township; and

WHEREAS, Downe Township has participated in the preparation of the Mitigation Plan for Four New Jersey Counties, a multi-jurisdictional, multi-hazard mitigation plan in accordance with the Disaster Mitigation Act of 2000; and

WHEREAS, the Mitigation Plan for Four New Jersey counties includes:

1. The Regional Hazard Mitigation Plan and Annexes that include summary information common to all participating jurisdictions in the four county region, and
2. The Downe Township Appendix that identifies mitigation goals, strategies, and measures specifically for Downe Township to reduce or eliminate long-term risk to people and property from the impacts of future hazard events and disasters; and

WHEREAS, adoption by the Downe Township Committee demonstrates commitment to hazard mitigation and achieving the goals outlines in the Mitigation Plan for Four New Jersey Counties;


NOW, THEREFORE, in accordance with Downe Township Committee, be it resolved by Downe Township, Cumberland County, New Jersey, that;


The Township of Downe adopts the Mitigation Plan for Four New Jersey Counties and the Downe Township Appendix including authorizing the formation and duties of the Downe Township Hazard Mitigation Working Group as follows:

1. The Working Group shall be convened by the Downe Township Emergency Management Coordinator and will include representative of the following departments, agencies, and organizations and other interested parties;
2. The Working Group shall convene to conduct plan implementation and maintenance activities as identified in the Regional Hazard Mitigation Plan and Downe Township Appendix including monitoring, evaluation, and updating the Downe Township Appendix and providing annual reports to the Downe Township Committee and the Cumberland County Office of Emergency Management.

THIS RESOLUTION was adopted by the Township Committee of the Township of Downe on October 3, 2016.
