Liz Cowley of Fortescue stated that Saturday the Green Team will be doing a waterway and beach cleanup. All of the township waterways will be cleaned. We are looking for more volunteers especially young ones. We will meet at the OEM building at 8:30am on Saturday morning. Liz mention there are a few bad potholes in the township that need attention. Liz stated Laurie and Maureen are responsible for the display you see that illustrates how long it takes for items to decompose. The display will be stationed at the Elementary School for a contest with the students next. Mayor Rothman commented the Green Team is doing a great job in the township.

Kary Wilson of Newport asked for details on resolution R-88-2021. Mr. Campbell stated the Building Resilient Infrastructure and Communities program (BRIC) grant is a grant to help lower flood insurance premiums through the Community Rating System (CRS).

Kary Wilson asked for details on resolution R-89-2021. Mr. Campbell answered this resolution is for a FEMA grant for a flood mitigation program to fund structure elevation, infrastructure improvement and flood mitigation planning.

Mrs. Wilson asked if a copy if available online of the agreement mention in resolution R-90-2021. Are their plans already prepared? Mr. Campbell stated we are working with the NJDOT appointed engineering firms to do the design at no cost to the township. It has taken month to put 3 different agreements together for the project. We are currently waiting on the last agreement to be signed. After which, the project will start.

Mrs. Wilson asked who is the Fair Housing Officer? Mayor Rothman answered Ms. Lockley. Mrs. Wilson asked what are the topics for Executive Session? Mrs. Bertram answered litigation of John Paff vs Township of Downe, contracts with the Zoning Office and possible eminent domain.

Doug Cook of Fortescue asked what the change is the Township is referencing in Ordinance 2021-10. Mrs. Bertram answered we are just clarifying that we accept the way the County has set forth the opportunity to get the septic waiver. The ordinance requires an inspection or a waiver for the septic system.

Mr. Campbell reported the sewer project is into the DEP for permitting. We are getting very close to having our permits. We will be holding a Public Hearing as part of the permit process soon. It was a possibility for our October meeting, but we were informed by the State that date would need to be pushed back.
