She asked that we do some coordinating with the South Jersey Gas Company installation and the Horseshoe Crab Festival so that the roadways will be clean for the event.

Sean Pignatelli asked if the school playground open to be used by township residents even when the school is closed. He asked if the committee would entertain putting in a few parks in the township. Mayor Rothman comments discussions have taken place regarding this issue. The biggest problem is AT THIS POINT THERE IS AN ISSUE WITH THE RECORDING.

Liz Cowley commented that a lot of the comments she has been receiving has been about small recreational areas needed throughout the township possibly one in each village.
