Mayor Rothman reported the County is working on replacing the weight limit signs that were missing at the south end bridge. We are working on the dune situation that was bought up last month. There is an issue on Turkey Point Road with dumping cats. There is a request from a resident on Turkey Point Road to install "illegal cat dumping signs" in the area to stop the action. We have received some complaints about the condition of Pennsylvania Avenue. The township has put some fill dirt down as a temporary fix. We have spoken with the property owner of the trailer park today and he is in the process of eviction of some tenants and will be cleaning up the property. We have put up some signage on Maple Avenue and we are waiting on the county who has agreed to work on making the area safe with signs and fencing.

HEART AND SOUL PRESENTATION

Jamie Warner of Dividing Creek gave a brief overview of what's happening with the Heart and Soul Project. The process entails reaching out to the community to find out what we all love about Downe Township and use that data to create an action plan for the future of the township. We have spent part of last year collecting data from over 650 residents and visitors of Downe Township. We grouped the data by theme and created value statements. Mrs. Warner read over the value statements hoping to collect feedback from the attendees of the meeting. The next thing to do is create an action plan. We now have some money that we can throw behind some projects for the township. We need your feedback. The committee thanked the Heart and Soul Project team for all of their hard work.

Meghan Wren of Fortescue stated if there are any comments to the value statements or if there is something you think the township should be doing that we didn't address, please contact Jamie or Meghan because we are still working on the draft.

Liz Cowley of Fortescue stated that on March 25th we will be doing a roadway cleanup in Dividing Creek on Narrow Lane Road towards Millville. We meet at the OEM building at 8am. On March 26th we will be sponsoring a lecture on Nature at the Newport Methodist Church from 2pm-4pm. We will be featuring two rehabilitators, one from Conserve Wildlife and one from Wildlife Rehabilitators. We are happy to announce that Vicki from Wildlife Rehabilitators is now a resident of Fortescue. We will be learning what to do when we have injured animals or other wildlife in this area. About a week ago we had a seal rescued in Fortescue.

Mr. Bart reported the state has been working on cleaning up Money Island.

Mr. Byrne stated music will begin again starting on March 18th at 2pm with the Fiddle Club of Linwood. The Austin Brothers will be performing on April 15th at 7pm. Don't forget our one Sunday a month music session from 1pm-4pm.

Mr. Campbell stated we are waiting for the bids to come in on March 30th. Everything is on track. Mr. Pignatelli asked if the DEP had signed everything and are we ready to go. Mayor Rothman stated there is one issue with the DEP regarding the legal wording of a document that is being worked on and will be resolved shortly. This is not holding us up. There is nothing holding us up at this point, that is why we were able to go out for bids. Mayor Rothman explained the conditions of the construction. There are seasons we can not do construction because of eagles & osprey nesting in the area. When the bids are opened, we will know what the project will cost.

Mr. Campbell also spoke about the three FEMA projects we are working on. The projects are the Fortescue Cap project, the new seawall in Gandy Beach and the repair of the steel bulkhead in Gandy Beach.
