Mayor Rothman gave the following updates. There has been some movement with the paving repairs on Fortescue Road. Maple Avenue is still being discussed with the County. There has been some positive progress with code enforcement violation notices for property cleanups. The Horseshoe Crab Festival is scheduled for May 13th. Lastly the budget will have a 4.4 cent increase. We have worked very hard to keep this number low. All of the municipalities in the State are facing an increase. There has been a large increase in the State Pension program and also the State Health Benefits Program. There is an increase in the cost of just about everything in this world.

Kary Wilson of Newport asked what dollar amount is needed to justify the increase you spoke about. Mrs. Sbrolla answered the amount is about \$250,000. Is Downe Township providing shared services or receiving shared services. Miss Lockley answered we are in a contract with the Borough of Shiloh. What is the discharge and cancellation of mortgage resolution for? Miss Lockley answered this is a Home Rehab Program grant that is being paid back because the house is being sold.

Bob Pignatelli of Fortescue asked for an update on the Fortescue Sewer Project. Mayor Rothman announced an update will be given during the Committee Reports.

There being no further comments, the public comment portion was closed on a motion by Jordan and seconded by Campbell.

## **COMMITTEE REPORTS**

Mayor Rothman reported the sewer project is moving forward. There is a mandate that when you borrow federal funds you must now "Buy America Build America" (BABA). Originally, we were told we would receive a waiver for BABA. We have now been told the federal government has rescinded our waiver for BABA. This made us have to amend our original specs to include BABA and go out for bids at a later date. Addendums must be issued for the changes in the bid specifications. All of this has just changed the bid opening dates for the project. The project is still moving forward.

Mr. Pignatelli asked how long before we have a serious issue due to all of these delays. Mayor Rothman stated the delays move the project back, but we are also restricted from starting any construction projects until August because of the eagles and osprey.

Mrs. Wilson of Newport commented that since the bid opening date has been moved, does that allow other bidders to submit. Mayor Rothman commented yes.

Mr. Jordan stated he has nothing to report at this time.

Mr. Bart stated he has nothing to report at this time.

Mr. Byrne stated music will be at Union Hall this Saturday night at 7pm and the Austin Brothers will be performing. Last month there was standing room only. The parking lots were full for the Fiddle Club of Linwood. Don't forget our one Sunday April 15<sup>th</sup> for our monthly music session from 1pm-4pm. There is also great music planned for the Horseshoe Crab Festival on May 13<sup>th</sup>.

Mr. Campbell stated he had nothing to report.

Lastly Mayor Rothman thanked everyone for showing up month after month to see what's going on in your community.
