ORDINANCE NO. 2021-3

ORDINANCE OF THE TOWNSHIP OF DOWNE AUTHORIZING THE VACATION OF SURF AVENUE

WHEREAS, the residents adjacent to Surf Avenue, being Robert G. and Monica M. Howell and William and Betsy Ann Osterman have requested that the Township of Downe vacate the entirety of Surf Avenue and permit each landowner to add a portion of such land to their properties; and

WHEREAS, this Avenue is not improved or open for traffic by the public and of no use to the Township of Downe; and

WHEREAS, the Township Committee of the Township of Downe is desirous of vacating Surf Avenue and permitting the adjacent landowners the opportunity to divide the land between themselves; and

WHEREAS, the legal descriptions of the street/avenue to be vacated are attached hereto and made a part hereof as Exhibit A;

- NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Downe, that Surf Avenue, more accurately described in the description attached hereto as Exhibit A, and made a part hereof, be and are hereby vacated and the property consisting of Surf Avenue are hereby conveyed to the adjoining property owners on both sides; and
- BE IT FURTHER ORDAINED that in accordance with N.J.S.A. 40:67-1 (b) and N.J.S.A. 40:67-21, within 60 days of the date hereof, the Clerk of the Township of Downe shall file a copy of this Ordinance under the seal of the Township of Downe certified to be a true copy thereof, together with a copy of the proof of publication with respect to the publication of this Ordinance with the recorder of Deeds at the County of Cumberland to be recorded in the property index in a book of records entitled "vacations"; and
- **BE IT FURTHER ORDAINED** that the vacation of the aforesaid lands known as Surf Avenue shall become part of the tax lot and block designations of the lands owned by the adjacent property owners on both sides according to the terms hereof; and

- BE IT FURTHER ORDAINED that the adjacent landowners shall record all-inclusive deeds with full legal descriptions including the land hereby vacated at the expense of the landowners.
- BE IT FURTHER ORDAINED that the Township of Downe expressly reserves and excepts from vacation all rights and privileges then possessed by public utilities, as defined in R.S. 48:2-13, and by any cable television company, as defined in the "Cable Television Act", P.L. 1972, c. 186 (C. 48:5A-1 et seq.), to maintain, repair and replace their existing facilities in, adjacent to, over or under the street, highway, lane, alley, square, place or park, or any part thereof, to be vacated.
- **BE IT FURTHER ORDAINED** that a copy of this Ordinance, proof of publication, recording information and any all-inclusive Deeds shall be provided to the Tax Assessor of the Township of Downe.
