ORDINANCE 2021-12

AN ORDINANCE AMENDING ORDINANCE 2020-4 CONCERNING
THE ACQUISITION OF BLOCK 13, LOT 10

WHEREAS, the Township of Downe has previously enacted Ordinance 2020-4 (introduced February 10, 2020 and final adoption March 9, 2020) concerning the acquisition of Block 13, Lot 10 in the Township of Downe; and

WHEREAS, the Township has determined that it would be appropriate to fund the purchase by using capital funds and hereby directs the payment of such sum from that account; and

WHEREAS, all other provisions of Ordinance 2020-4 shall remain unchanged.

NOW, THEREFORE, BE IT ORDAINED by the Township of Committee of the Township of Downe, County of Cumberland and State of New Jersey that the purchase price for the property identified as Block 13, Lot 10 shall be paid from capital funds and the Mayor and Clerk are authorized to execute any documents necessary to bring such transaction to conclusion.

BE IT FURTHER ORDAINED, that this Ordinance shall take effect after final approval and publication as required by law.

ADOPTED at a Regular Meeting of the Township of Downe Township Committee meeting held on December 13, 2021.


