ORDINANCE NO. 2002-04

AN ORDINANCE PROVIDING FOR THE USE OF CAPITAL FUNDS FOR THE PURCHASE OF NEW, ADDITIONAL OR REPLACEMENT PUBLIC WORKS AND GENERAL OFFICE EQUIPMENT AND IMPROVEMENTS FOR MUNICIPAL BUILDINGS AND STRUCTURES, AND TO APPROPRIATE THE SUM OF \$56,700.00 TO PAY THE COST THEREOF

WHEREAS, the Mayor and Committee of the Township of Downe have recognized the need to replace or purchase equipment for Public Works and the General Office and improvements need for Municipal Buildings and Municipal Structures;

NOW, THEREFORE, BE IT ORDAINED, by the Township of Downe, County of Cumberland, State of New Jersey, as follows:

SECTION ONE

AUTHORIZATION TO MAKE NEEDED PURCHASE

The Township of Downe, in the County of Cumberland, State of New Jersey (the "Township") is hereby authorized to make various public improvements and to acquire new additional or replacement equipment and machinery, new systems and equipment including original apparatus and equipment, in, by and for said Township. Said improvements shall include all work, materials and appurtenances necessary and suitable therefore.

SECTION TWO

AUTHORIZING THE USE OF CAPITAL FUNDS

There is hereby appropriated to the payment of the cost of making the improvements described in Section 1 hereof (hereinafter referred to as "purposes"), the respective amount of money hereinafter stated as the appropriation for said respective purposes. Said appropriation shall be met from Capitol Funds. Said improvements shall be made as general improvements and no part of the cost thereof shall be assessed against property specially benefited.

SECTION THREE

AUTHORIZING THE PURCHASE AS A CAPITAL IMPROVEMENT

It is hereby determined and stated that the making of such improvements is not a current yearly budget expense of said Township.

- Section 1. Repealer. All ordinances or parts thereof which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of their inconsistencies.
- Section 2. Severability. In the event any section, part or provision of this Ordinance shall be held unconstitutional or invalid by any Court, such holding shall not affect the validity of this Ordinance or any remaining part of this Ordinance other than the part held unconstitutional or invalid.

Section 3. This Ordinance shall take effect after final approval and publication as required by law.
