WHEREAS, the date of this Resolution is within the first thirty (30) days of January 2017; and

WHEREAS, the total appropriations in the 2016 budget, exclusive of any appropriations made for interest and debt redemption charges, capital improvement funds, and public assistance is the sum of \$908,504.00; and

WHEREAS, twenty six and one quarter percent of the total appropriations in the 2016 budget exclusive of any Page 1 of 5

appropriations made for interest and debt redemption charges and capital improvement fund in said 2016 budget is the sum of \$238,482.30.
