**RESOLUTION APPOINTING ATTORNEY TOM SEELEY, ESQUIRE AS SPECIAL  
COUNSEL FOR THE HANDLING OF CERTAIN MATTERS BY THE DOWNE  
TOWNSHIP COMMITTEE**

**WHEREAS,** the Downe Township Committee is charged with handling the affairs of the Township and in that context has a desire to appoint Tom Seeley, Esquire, a licensed New Jersey Attorney, to handle certain matters on behalf of the Township of Downe to include certain tax sale foreclosures as are enumerated in the annexed; and,

**WHEREAS,** the Township of Downe has a need and desire to acquire such professional services by Tom Seeley, Esquire, a licensed New Jersey Attorney, under a Non-Fair and Open Contract pursuant to N.J.S.A. 19:44A-20.5; and,

**WHEREAS,** the Local Public Contracts Law may require this Resolution authorizing the award of the contract for professional services without competitive bidding and contract itself to be available for public inspection;

**NOW, THEREFORE, BE IT RESOLVED,** by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey that the Mayor and Clerk are hereby authorized to execute a Non-Fair and Open Contract pursuant to N.J.S.A. 19:44A-20.5 with Tom Seeley, Esquire for professional services tax foreclosures on certain properties as are enumerated in the annexed (A);


**AND, THEREFORE, BE IT FURTHER RESOLVED,** this Contract in a form as is annexed (B) is awarded without competitive bidding as a professional service in accordance with N.J.S.A. 40A:11-5 (1) (a) of the Local Public Contracts Law due to the services to be rendered being required to be performed by a qualifying professional;

**AND, THEREFORE, BE IT FURTHER RESOLVED,** that the Business Disclosure Entity Certification, the Political Contribution Disclosure and any and all other reasonably necessary documentation shall be placed on file together with this Resolution and a copy of this Notice of Action shall be printed in accordance with New Jersey Law, if applicable.
