**RESOLUTION APPROVING CONTRACT CHANGE ORDER NO. 2
ON UNION STREET REPAIR BY ASPHALT PAVING CORPORATION**

WHEREAS, the Asphalt Paving Corporation and the Township of Downe had heretofore entered into an Agreement for the repair of Union Street situate in Downe Township, Cumberland County, New Jersey detailing the furnishing of labor, equipment and materials; and,

WHEREAS, during the course of the project, Change Order No. 1 was prepared and entered into by virtue of Resolution 56-2017 by the Downe Township Committee at which time the project scope having been updated, the project price was updated consonant with N.J.A.C. 5:30-11.9, A through D; and,

WHEREAS, the project having been substantially completed pursuant to a report from Township Engineer and the final price coming in under the total approved amount, it becomes necessary to update the Change Order to reflect the final approved amount based upon the substantial completion of the project on July 15, 2017;

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey that that project originally considered under Resolution R-89-2016 and updated by virtue of Resolution R-56-2017, be


updated pursuant to the requirements of New Jersey Law to reflect a final cost based upon that form SA-1 dated 9-1-2017 attached hereto and incorporated herein by reference reducing the amended amount of the project from \$172,562.50 to \$167,763.50;

AND, BE IT FURTHER RESOLVED, that the Township Clerk may hereby be authorized to execute Change Order No. 2 and is further directed to adhere to the requirements of New Jersey Law and in particular N.J.A.C 5:30-11.9 as to the publication of the Change Order and addition of the change to the fiscal year record for 2017.

THIS RESOLUTION was adopted by the Township Committee of the Township of Downe on September 11, 2017.
