**AWARDING JERRY AND SON EXCAVATING, INC.  
THE CONTRACT FOR THE PAVING OF RUSSELL LANE**

**WHEREAS**, the Township of Downe was awarded funding in the amount of \$67,000 from the New Jersey Department of Transportation's (NJDOT) Municipal Aid Program for improvements to Russell Street located in Dividing Creek; and,

**WHEREAS**, Tedesco Engineering LLC, was contracted to prepare construction plans and specifications, prepare bidding documents, and conduct the bid opening.

**WHEREAS**, in accordance with the Local Public Contracts Law, bids were received on September 29, 2017 for the Paving of Russell Lane and Tedesco Engineering LLC, has provided a recommendation for award to perform the necessary road paving;

**WHEREAS**, Tedesco Engineering LLC, has determined that the lowest responsible bidder was Jerry and Son Excavating, Inc. of 5981 Scranton Avenue, Mays Landing, NJ 08330 in the amount of \$34,860.00.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey as follows:

1. Subject to the concurrence of the Commissioner of the New Jersey Department of Transportation, Jerry and Son Excavating, Inc. is hereby awarded a contract in the amount of \$34,860.00 for the paving of Russell Lane in accordance


with the plans and specifications prepared by Tedesco Engineering LLC.

**THIS RESOLUTION** was adopted by the Township Committee of the Township of Downe on October 9, 2017.


