**AUTHORIZING PURCHASE FROM NEW JERSEY STATE CONTRACT VENDOR FOR
ONE (1) 2018 F350 DUMP TRUCK (CHERRY HILL WINNER FORD)**

WHEREAS, pursuant to N.J.S.A. 40A:11-12, local government contracting units may purchase materials, supplies, services or equipment without advertising for bids under any contract for the purchase of such items entered into on behalf of the State of New Jersey by the New Jersey Department of the Treasury, Division of Purchase and Property; and;

WHEREAS, the Township of Downe desires to enter into an agreement with New Jersey State Contract Vendor - Cherry Hill Winner Ford, 250 Haddonfield-Berlin Road, Cherry Hill, NJ 08034 to provide one (1) 2018 F350 Dump Truck in accordance with the terms and conditions of the current New Jersey State Contract No. A88758, T2101 (Vehicles, Trucks, Class 3, Pickup/Utility/Dump, with Snow Plow Option).


NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey as follows:

1. That a contract is hereby awarded to New Jersey State Contract Vendor Cherry Hill Winner Ford in the amount of \$69,002.00 to provide one (1) 2018 F350 Dump Truck in accordance with the terms and conditions of the current New Jersey State Contract No. A88758, T2101 (Vehicles, Trucks, Class 3, Pickup/Utility/Dump, with Snow Plow Option).

2. That said purchase is through a United States Department of Agriculture Community Facility Grant Program awarded to the Township of Downe in the amount of \$51,500 with a Township match of \$17,502.00. The Township match shall be charged to Line Item Appropriation or Account No. G-02-41-871-001 and C-04-44-900-407.
