RESOLUTION ADOPTING THE 2019 TEMPORARY BUDGET

WHEREAS, N.J.S. 40A:4-19 provides that where any contract, commitment or payments are to be made prior to the final adoption of the 2019 budget, temporary appropriations should be made for the purpose and amounts required in the manner and time therein provided; and

WHEREAS, the date of this Resolution is within the first thirty (30) days of January 2019; and

WHEREAS, the total appropriations in the 2018 budget, exclusive of any appropriations made for interest and debt redemption charges, capital improvement funds, and public assistance is the sum of \$965,888.00; and

WHEREAS, twenty six and one quarter percent of the total appropriations in the 2018 budget exclusive of any appropriations made for interest and debt redemption charges and capital improvement fund in said 2018 budget is the sum of \$253,545.60.

NOW, THEREFORE, BE IT RESOLVED that the following appropriations be made and that a certified copy of this Resolution be transmitted to the CFO for his records:
