AUTHORIZNG PROFESSIONAL SERVICES AGREEMENT WITH JAMES M. RUTALA ASSOCIATES, LLC. AS GRANT PROGRAM COORDINATOR FOR A ONE (1) YEAR TERM

WHEREAS, there exists a need to employ and contract for professional services for the year 2019; and

WHEREAS, the Township Committee of the Township of Downe desires to engage the professional services of James M. Rutala Associates, LLC to provide Grant Planning and Coordinator services for the Township of Downe:

WHEREAS, the Township shall pay the Grant Coordinator, James M. Rutala at the rate of \$140.00 an hour plus expenses for services rendered to Downe Township

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.) requires that a Resolution authorizing the award of contracts for "Professional Services" without competitive bids and the contract be made available for public inspection:

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey, as follows:

- The Downe Township Committee hereby authorizes the Mayor and Acting Clerk to execute a form of Agreement with James M. Rutala Associates, LLC of 717 River Drive, Linwood, New Jersey 08221 for a one (1) year term.
- The contract is awarded without competitive bidding as a "Professional Service" in accordance with N.J.S.A. 40A:11-5 (1)(a)(i) of the Local Public Contracts Law because the Page 1 of 2

services of the provider are specialized and qualitative in nature and such services cannot be reasonably described by written specification and extensive training and certification are required to satisfactorily provide such services pursuant to applicable New Jersey State Law.

3. A notice of this action shall be published one time in an official newspaper of the Township of Downe in accordance with $N.J.S.A.\ 40A:11-5(1)(a)(i)$.
