**RESOLUTION APPOINTING TAX MAP MAINTENANCE
LAND SURVEYOR FOR A ONE (1) YEAR TERM**

WHEREAS, the Township Committee desires to appoint a Professional Land Surveyor for the purpose of maintaining and certifying the Tax Maps of the Township of Downe; and

WHEREAS, the Township of Downe desires to contract with Fralinger Engineering, PA, for the purposes of providing the services of Tax Map Maintenance Engineer; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.) requires that a Resolution authorizing the award of contracts for "Professional Services" without competitive bids and the contract be made available for public inspection:

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey, as follows:

1. The Downe Township Committee hereby authorizes the Mayor and Acting Clerk to execute a form of Agreement with Fralinger Engineering, PA of 629 Shiloh Pike, Bridgeton, NJ 08302, for a period of one (1) year beginning January 7,


2019 through the date of Reorganization 2020 as Tax Map Maintenance Engineer.

2. The contract is awarded without competitive bidding as a "Professional Service" in accordance with N.J.S.A. 40A:11-5 (1)(a)(i) of the Local Public Contracts Law because the services of the provider are specialized and qualitative in nature and such services cannot be reasonably described by written specification and extensive training and certification are required to satisfactorily provide such services pursuant to applicable New Jersey State Law.
3. A notice of this action shall be published one time in an official newspaper of the Township of Downe in accordance with N.J.S.A. 40A:11-5(1)(a)(i).
