## RESOLUTION APPROVING THE 15<sup>TH</sup> ANNUAL NEW JERSEY DEVILMAN TRIATHLON TO OCCUR ON SUNDAY, MAY 5, 2019 IN THE TOWNSHIP OF DOWNE

WHEREAS, Kinetic Endeavors, LLC, dba Kinetic Multisports has requested permission to use the roads within the Township of Downe on Sunday, May 5, 2019 for the purpose of conducting bike and run portions of the race for the 15th Annual New Jersey Devilman Triathlon; and

WHEREAS, the Township Committee of the Township of Downe has determined that the use of its roads for the aforementioned race will not unduly burden the residents of the Township of Downe, subject to the following terms and conditions;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Downe, as follows:

1. Kinetic Endeavors, LLC, dba Kinetic Multisports is permitted to conduct bike and run portions of a race known as the 15<sup>th</sup> Annual New Jersey Devilman Triathlon on the roads in the Township of Downe on Sunday, May 5, 2019. See copy of Cover Course, Bike Course (1 & 2) and Run Course (1 & 2) annexed hereto as **Exhibit A**.

- 2. Kinetic Endeavors, LLC, dba Kinetic Multisports shall name the Township of Downe as an additional insured on its policy of insurance insuring the Township of Downe for any and all claims or liabilities arising out of the triathlon.
- 3. Kinetic Endeavors, LLC, dba Kinetic Multisports will execute a Hold Harmless/ Indemnification Agreement, a copy of which is annexed hereto as **Exhibit B** and made a part hereof.
- 4. Kinetic Endeavors, LLC, dba Kinetic Multisports will take all actions necessary in order to remove any and all debris following the bike and run portions of the race on all roads within the Township of Downe.
