**RESOLUTION APPROVING THE ENGINEERS PROPOSAL FOR
DELAWARE AVENUE CONSTRUCTION SPECIFICATIONS AND
INSPECTION SUPPORT SERVICES**

WHEREAS, the Township of Downe has been selected to receive funding from the New Jersey Department of Transportation's (NJDOT) Municipal Aid Grant Program (MA-2019-Delaware Avenue-00408) for improvements to Delaware Avenue located in Fortescue in the amount of \$200,816.00; and

WHEREAS, the Township of Downe received a proposal from Tedesco Engineering, LLC to provide construction plans / specifications, bidding documents and inspection support for the milling/grading/paving of Delaware Avenue:

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Downe in the County of Cumberland, State of New Jersey, hereby approves the proposal received from Tedesco Engineering, LLC, 811 Landis Avenue, Bridgeton, NJ 08302 as annexed hereto for the Delaware Avenue Project.


NOW THEREFORE, BE IT FURTHER RESOLVED by the Township Committee of the Township of Downe, as follows:

1. Tedesco Engineering, LLC., is hereby approved to provide construction plans, specifications, bidding documents, and construction field inspection/observation support for the paving of Delaware Avenue in Fortescue in the Township of Downe for an amount not to exceed \$19,100.00 in accordance with a proposal which is annexed hereto and made a part hereof as **Exhibit A**.
2. The Mayor and Township Clerk are hereby authorized to execute the proposal from Tedesco Engineering, Inc., annexed hereto as **Exhibit A**.
