**RESOLUTION SEEKING PROPOSALS FOR THE CONSTRUCTION  
AND INSTALLATION OF A SOLAR ENERGY SYSTEM ON DOWNE  
TOWNSHIP OWNED LAND**

**WHEREAS**, the Downe Township Committee is responsible for maintaining Municipality owned ground and undertakes to take such steps as are necessary in order to seek to best benefit the community; and

**WHEREAS**, Downe Township has been approached by several solar energy companies seeking to partner for the use of ground or lease the ground for an annual rent; and

**WHEREAS**, it is hereby determined by the Township Committee of the Township of Downe that the Township wishes to utilize this Township owned property in a manner that will fulfill a Federal, State and local goal of providing for the encouragement and promotion of the efficient use of natural resources and the installation and usage of renewable energy systems in a manner that will best benefit the residents of the Township through the best utilization of the subject Township owned property.


**NOW, THEREFORE, BE IT RESOLVED,** by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey that the Township Committee does hereby approve the formal request for proposals in a form such as is annexed hereto for purposes of seeking to determine a solar energy related use that best benefits the Township of Downe relating to grounds owned by Downe Township known as Block 27, Lot 3, in the Township of Downe, County of Cumberland and State of New Jersey;
