**RESOLUTION AUTHORIZING EXECUTION OF AN ENCROACHMENT  
AGREEMENT PERTAINING TO 184 SOUTH COVE ROAD, GANDY'S  
BEACH**

**WHEREAS,** the Township Committee of the Township of Downe is responsible for running various aspects of the Township to include maintenance of the public right-of-ways therein; and

**WHEREAS,** it has come to the attention of the Township that an encroachment exists on property known as 184 South Cove Road, Gandy's Beach, New Jersey also known as Block 57, Lot 8, situate in Downe Township, County of Cumberland and State of New Jersey; and


**WHEREAS,** the encroachment appears to be a historic one of a bulkhead which was constructed many years ago which partially intrudes onto Township property known as Block 57, Lot 9 which was donated to the Township by the current Owners of 184 South Cove Road; and


