## RESOLUTION OPPOSING NEW JERSEY BECOMING A SANCTUARY STATE AND RESOLVING THAT DOWNE TOWNSHIP, CUMBERLAND COUNTY NEVER BECOMES A SANCTUARY CITY

WHEREAS, the Governor of the State of New Jersey and the New Jersey Legislature stated that New Jersey should become a Sanctuary State; and

WHEREAS, cities throughout the nation and within this State have declared that they are "Sanctuary Cities"; and

WHEREAS, a Sanctuary State means that the State of New Jersey would welcome illegal undocumented immigrants; and

WHEREAS, Governor Phil Murphy and the New Jersey Legislature has enacted legislature providing benefits to illegal undocumented immigrants; and

WHEREAS, the Township Committee of the Township of Downe opposes New Jersey becoming a Sanctuary State as New Jersey has some of the highest property taxes in the nation and the Governor of the State of New Jersey and the New Jersey

Legislature should be more concerned with reducing spending and property tax reduction for the legal residents and taxpayers of the State of New Jersey; and

WHEREAS, the governing body of the Township of Downe shall continue to put the needs of the residents of Downe Township first and thereby determining that Downe Township shall never be a Sanctuary City; and

WHEREAS, the governing body of the Township of Downe urges Governor Phil Murphy and the New Jersey Legislature to reevaluate their position with regard to New Jersey becoming a Sanctuary State;

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey that the Township Committee of the Township of Downe opposes New Jersey becoming a Sanctuary State and urges Governor Phil Murphy and the New Jersey Legislature to reevaluate their position and to instead focus on the health, safety and general welfare of the residents and taxpayers of the State of New Jersey; and

BE IT FURTHER RESOLVED, that Downe Township shall never become a Sanctuary City and that all local, state and federal laws shall be strictly enforced, and the residents of Downe Township shall be the primary concern of the governing body; and

BE IT FURTHER RESOLVED, that the Downe Township Clerk shall forward a certified true copy of this Resolution to the Governor of the State of New Jersey, Lieutenant Governor of the State of

New Jersey, the members of the Cumberland County Legislative Delegation and the members of the Cumberland County Board of Chosen Freeholders.
