WHEREAS, it is necessary for the Township Committee of the Township of Downe to discuss in a session not opened to the public certain matters relating to the item or items authorized by *N.J.S.A. 10:4-12b* and designated below as follows:


1. *Matters relating to anticipated litigation, personnel and contract negotiations in which the public body may become a party pursuant to N.J.S.A. 10:4-12b(7)*


