**AUTHORIZING PURCHASE FROM NEW JERSEY STATE CONTRACT VENDOR FOR  
ONE (1) 2019 JCB 3CXG14 BACKHOE (FARM RITE EQUIPMENT)**

**WHEREAS**, pursuant to N.J.S.A. 40A:11-12, local government contracting units may purchase materials, supplies, services or equipment without advertising for bids under any contract for the purchase of such items entered into on behalf of the State of New Jersey by the New Jersey Department of the Treasury, Division of Purchase and Property; and;

**WHEREAS**, the Township of Downe desires to enter into an agreement with New Jersey State Contract Vendor - Farm Rite, Inc., PO Box 29, Shiloh, NJ 08353, Ship to: 122 Old Cohansey Road. Bridgeton, NJ 08302 to provide one (1) 2019 JCB 3CXG14 Backhoe in accordance with the terms and conditions of the current New Jersey State Contract No. A43035, T2187 (Parts and Repairs for Lawn and Grounds Equipment).

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey as follows:

1. That a contract is hereby awarded to New Jersey State Contract Vendor Farm Rite, Inc., in the amount of \$82,345.00 to provide one (1) 2019 JCB 3CXG14 Backhoe in accordance with the terms and conditions of the current New Jersey State Contract No. A43035, T2187 (Parts and Repairs for Lawn and Grounds Equipment).

2. That said purchase is through a United States Department of Agriculture Community Facility Grant Program awarded to the Township of Downe in the amount of \$37,900 with a Township match of \$44,445.00. The Township match shall be charged to Line Item Appropriation or Account No. C-04-44-900-521.
