## APPROVAL TO SUBMIT A GRANT APPLICATION LAIF-DOWNE TOWNSHIP-00050 AND EXECUTE GRANT AGREEMENT WITH THE NEW JERSEY DEPARTMENT OF TRANSPORTATION

WHEREAS, the New Jersey Department of Transportation accepts applications for the Local Aid Infrastructure Fund; and

WHEREAS, the program is available to all counties and municipalities in the State of New Jersey; and

WHEREAS, the Local Aid Infrastructure Fund is established to address emergencies and regional needs throughout the State; and

WHEREAS, these projects are approved at the discretion of the Commissioner; and

WHEREAS, the grant program does not require a local match;
and

WHEREAS, the Township of Downe carefully considers grant programs that assist the Township in achieving projects and programs that are priorities for the community; and

WHEREAS, the Township of Downe wishes to apply to the Local Aid Infrastructure Fund to fund road paving associated with the Downe Township Sewer Project; and

NOW THEREFORE, BE IT RESOLVED that the governing body of the Township of Downe formally approves a Local Aid Infrastructure Fund grant application.

BE IT FURTHER RESOLVED that the Mayor and Clerk are hereby authorized to submit an electronic grant application identified as LAIF-Downe Township-00050 to the New Jersey Department of Transportation on behalf of the Township of Downe.

BE IT FURTHER RESOLVED, that the Mayor and Clerk are hereby authorized to sign the grant agreement on behalf of the Township of Downe and that their signature constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement.
