WHEREAS, the Township of Downe carefully considers grant programs that assist the Township in achieving projects and programs that are priorities for the community; and


WHEREAS, the Township of Downe wishes to apply to the Local Aid Infrastructure Fund to fund road paving associated with the Downe Township Sewer Project; and


NOW THEREFORE, BE IT RESOLVED that the governing body of the Township of Downe formally approves a Local Aid Infrastructure Fund grant application.
