**WHEREAS**, the Township of Downe desires to enter into an agreement with New Jersey State Contract Vendor/Sourcwell Grounds Maintenance Contract Member #42546 - Vermeer North Atlantic Sales, 7 Maple Avenue, Lumberton, NJ 08048 to provide one (1) 2019 JCB 3CXG14 Backhoe in accordance with the terms and conditions of the current New Jersey State Contract No. A43035, T2187 (Parts and Repairs for Lawn and Grounds Equipment).


**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey as follows:



That a contract is hereby awarded to New Jersey State Contract Vendor/Sourcwell Grounds Maintenance Contract Member #42546 Vermeer North Atlantic Sales, 7 Maple Avenue, Lumberton, NJ 08048 in the amount of \$44,239.00 to provide one (1) BC1200XL Brush Chipper in accordance with the terms and conditions of the current New Jersey State Contract/Sourcwell Grounds Maintenance Contract 062117 / Member #42546.

2. That said purchase is through a United States Department of Agriculture Community Facility Grant Program awarded to the Township of Downe in the amount of \$37,900 with a Township match of \$44,445.00. The Township match shall be charged to Line Item Appropriation or Account No. C-04-44-900-521.
