RESOLUTION AMENDING AND RESTATING RESOLUTIONS R-10-2019 AND R-10-2020 RATIFYING THE APPOINTMENT OF THE OFFICE OF EMERGENCY MANAGEMENT COORDINATOR AND DEPUTY EMERGENCY MANAGEMENT COORDINATOR FOR THE TOWNSHIP OF DOWNE
