RESOLUTION PROVIDING FOR THE INSERTION OF ITEMS OF REVENUE IN THE BUDGET PURSUANT TO N.J.S.A 40A:4-87 CHAPTER 159, P.L. 1048)
USDA COMMUNITY FACILITY GRANT FOR \$27,800

WHEREAS, N.J.S.A 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item or revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget, and

WHEREAS, said Director may also approve the insertion of an item of appropriation for equal amount.

NOW THEREFORE, BE IT RESOLVED that the Township of Downe hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2020 in the sum of \$27,800.00 which item is now available as a revenue from United State Department of Agriculture (USDA) Rural Development Community Facilities Grant Program pursuant to the provisions of statute, and

BE IT FURTHER RESOLVED that a like sum of \$27,800.00 be and the same is hereby appropriated under the caption of USDA Community Facilities Grant-Public Works Truck

BE IT FURTHER RESOLVED that the sum of \$11,079.45 representing the amount required for the municipalities share of the aforementioned undertaking or Improvement appears in the budget of the year 2020 under the caption Capital Improvement Fund and is hereby appropriated under the caption of Matching Funds for Grants

NOW THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Downe hereby authorizes such action and that two copies of this resolution be filed with the Division of Local Government Services, New Jersey Department of Community Affairs for approval.
