**RESOLUTION PROVIDING FOR THE INSERTION OF ITEMS OF REVENUE IN THE  
BUDGET PURSUANT TO N.J.S.A 40A:4-87 (CHAPTER 159, P.L. 1048)  
USDA COMMUNITY FACILITY GRANT FOR \$28,100**

**WHEREAS**, N.J.S.A 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item or revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget, and

**WHEREAS**, said Director may also approve the insertion of an item of appropriation for equal amount.

**NOW THEREFORE, BE IT RESOLVED** that the Township of Downe hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year **2020** in the sum of **\$28,100.00** which item is now available as a revenue from **United State Department of Agriculture (USDA) Rural Development Community Facilities Grant Program** pursuant to the provisions of statute, and




