**WHEREAS**, the New Jersey Department of Transportation is accepting applications for the Local Freight Impact Fund Grant Program; and

**WHEREAS**, this program is established for the purpose of assisting counties and local municipalities with the mitigation of impacts on the local transportation system associated with the State's freight industry; and

**WHEREAS**, projects must have as a minimum 10% Large Truck Volume within the project limits. A traffic study must be submitted to support this information; and


**WHEREAS**, Downe Township carefully considers grant programs that assist the Township in achieving projects and programs that are priorities for the community; and


**NOW, THEREFORE, BE IT RESOLVED** that governing body of the Township of Downe formally approves a grant application for a municipal aid project.
