## AUTHORIZING PURCHASE FROM NEW JERSEY STATE CONTRACT VENDOR FOR ONE 2020 FORD F150 TRUCK (LILLISTON FORD DEALERSHIP)

WHEREAS, pursuant to N.J.S.A. 40A:11-12, local government contracting units may purchase materials, supplies, services or equipment without advertising for bids under any contract for the purchase of such items entered into on behalf of the State of New Jersey by the New Jersey Department of the Treasury, Division of Purchase and Property; and

WHEREAS, the Township of Downe desires to enter into an agreement with New Jersey State Contract Vendor Lilliston Ford of 833 North Delsea Drive, Vineland, NJ 08360, State Contract Vendor ID Number V00017494 to provide one 2020 Ford F-150 Pickup Truck in accordance with the terms and conditions of the current New Jersey State Contract No. T-2099 (Vehicles, Trucks, Pickups, Class 1).

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey as follows:

That a contract is hereby awarded to New Jersey State 1. Contract Vendor Lilliston Ford, 833 North Delsea Drive, Vineland, NJ 08360 in the amount of \$40,045.00 to provide one (1) 2020 Ford F-150 Pickup Truck in accordance with the terms and conditions of the current New Jersey State Contract #T-2099.

2. That said purchase is through a United States Department of Agriculture Community Facility Grant Program awarded to the Township of Downe in the amount of \$27,800 with a Township match of \$12,245.00. The Township match shall be charged to Line Item Appropriation or Account No. G-02-41-871-005.
