**WHEREAS**, the Township Committee of the Township of Downe, is subject to certain requirements of the New Jersey Open Public Meetings Act (*N.J.S.A. 10:4-6, et seq.*); and

**WHEREAS**, the New Jersey Open Public Meetings Act (*N.J.S.A. 10:4-12*) provides that an executive session not opened to the public may be held for certain specified purposes when authorized by resolution; and

**WHEREAS**, it is necessary for the Township Committee of the Township of Downe to discuss in a session not opened to the public certain matters relating to the item or items authorized by *N.J.S.A. 10:4-12b* and designated below as follows:

1. *Matters relating to contract negotiations and property acquisition in which the public body may become a party pursuant to N.J.S.A. 10:4-12b(7)*

**NOW THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Downe assembled in public session on December 14, 2020, that an executive session closed to the public shall be held on December 14, 2020, in the Downe Township Municipal Complex located at 288 Main Street, Newport, New Jersey, for the discussions of matters related to the specific items designated above.


