**RESOLUTION DESIGNATING THOMAS J. TEDESCO, PE,  
AS PUBLIC AGENCY COMPLIANCE OFFICER FOR  
A ONE (1) YEAR TERM**

**WHEREAS,** *N.J.A.C. 17:27-3.2* requires each public agency to designate an officer or employee to serve as its Public Agency Compliance Officer; and

**WHEREAS,** the Public Agency Compliance Officer herein is required to perform the duties specified in the *New Jersey Administrative Code, Chapter 17*, and shall perform any other liaison and assistance functions as may be requested by the Division of Contract Compliance and Equal Employment Opportunity in Public Contracts; and

**WHEREAS,** the Municipal Engineer shall continue to have responsibility for compliance with bid specifications and public contracts for construction.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey that Thomas J. Tedesco, PE of TEDESCO ENGINEERING, LLC located at 182 Friesburg Road, Bridgeton, New Jersey 08302, is hereby designated as the Township's Public Agency Compliance Officer and shall perform the duties prescribed in *N.J.A.C. Title 17, Chapter 27* and shall perform any other liaison and assistance functions as may be requested by the Division of Contract Compliance and Equal Employment Opportunity in Public Contracts established in the State of New Jersey, Department of the Treasury;

**BE IT FURTHER RESOLVED**, that the term for the Public Agency Compliance Officer for the Township of Downe is effective January 4, 2021 through the date of Reorganization in January 2022,

**AND, BE IT FURTHER RESOLVED**, that the Municipal Engineer shall continue to perform the duties associated with determining compliance for construction bid specifications and contracts related to public construction contracts.
