RESOLUTION ADOPTING THE 2021 TEMPORARY BUDGET

WHEREAS, N.J.S. 40A:4-19 provides that where any contract, commitment or payments are to be made prior to the final adoption of the **2021** budget, temporary appropriations should be made for the purpose and amounts required in the manner and time therein provided; and

WHEREAS, the date of this Resolution is within the first thirty (30) days of January **2021**; and

WHEREAS, the total appropriations in the **2020** budget, exclusive of any appropriations made for interest and debt redemption charges, capital improvement funds, and public assistance is the sum of **\$1,482,808.00**; and

WHEREAS, twenty six and one quarter percent of the total appropriations in the **2020** budget exclusive of any appropriations made for interest and debt redemption charges and capital improvement fund in said **2020** budget is the sum of **\$389,237.00**.
