**RESOLUTION ENDORSING THE SUBMISSION OF A
RECYCLING TONNAGE GRANT APPLICATION
AND DESIGNATING INDIVIDUAL TO ENSURE
PROPER COMPLETION AND FILING**

WHEREAS, the Mandatory Source Separation and Recycling Act, P.L. 1987, c. 102 has established a recycling fund from which tonnage grants may be made to municipalities in order to encourage local source separation and recycling programs; and

WHEREAS, it is the intent and spirit of the Mandatory Source Separation and Recycling Act to use the tonnage grants to develop new municipal recycling programs and to continue to expand existing programs; and

WHEREAS, the New Jersey Environmental Protection has promulgated recycling regulations to implement the Mandatory Source Separation and Recycling Act; and

WHEREAS, the recycling regulations impose on municipalities certain requirements as a condition for applying for tonnage grants, including but not limited to, making and keeping accurate, verifiable records of materials collected and claimed by the municipality; and

WHEREAS, this resolution authorizing the municipality to apply for the 2021 Recycling Tonnage Grant will memorialize the commitment of this municipality to recycling and to indicate the assent of Downe Township to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling regulations; and


WHEREAS, such a resolution should designate the individual authorized to ensure that the application is properly completed and timely filed:

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Downe endorses the proper submission of the 2021 Recycling Tonnage Grant application to the New Jersey Department of Environmental Protection by Dennis DeMatte, CRP, Certified Recycling Coordinator and designates the same to ensure that the said application is timely filed; and

BE IT FURTHER RESOLVED that monies received from the Recycling Tonnage Grant be deposited into a dedicated Recycling Trust Fund to be used solely for the purposes of recycling.

THIS RESOLUTION was adopted by the Township Committee of the Township of Downe on March 8, 2021.
