**RESOLUTION AUTHORIZING THE TAX COLLECTOR TO CANCEL AND
REFUND PROPERTY TAXES ON BLOCK 23 LOT 219 DUE TO AN
ASSESSOR ERROR**

WHEREAS, the Tax Assessor, reported an erroneous assessment has been placed upon property known as Block 23 Lot 219, assessed to William Rhubert III, incorrectly in the amount of \$90,200 for the tax year 2020;

WHEREAS, the Tax Assessor reports the correct assessment for 2020 as \$30,000;

WHEREAS, N.J.S.A. 54:4-9-91.1, requires the Tax Collector to report any property taxes she believes are uncollectible due to an assessor error:

NOW, THEREFORE, BE IT RESOLVED:

1. That the governing body acknowledges the Tax Collector's report of uncollectible.
2. That the Tax Collector is hereby authorized to cancel the 2020 tax in the amount of \$1,456.84, due to the erroneous assessment.
3. The CFO is directed to refund the amount of \$1,093.84 to: Rhubert, William III, P.O. Box 137 Dividing Creek, NJ 08315

BE IT FURTHER RESOLVED that the Tax Collector of the Township of Downe is hereby authorized and directed to mark her records accordingly to reflect said refund and that the Chief Financial

Officer of the Township of Downe is hereby authorized and directed to prepare said refund for the above named.

This resolution shall become effective immediately upon adoption by the Township Committee of the Township of Downe as per meeting on May 10, 2021.
