**WHEREAS**, the New Jersey Open Public Meetings Act (N.J.S.A. 10:4-12) provides that an executive session not opened to the public may be held for certain specified purposes when authorized by resolution; and

**WHEREAS**, it is necessary for the Township Committee of the Township of Downe to discuss in a session not opened to the public certain matters relating to the item or items authorized by N.J.S.A. 10:4-12b and designated below as follows:

1. *Matters relating to personnel, possible litigation, land acquisition, and contract negotiations in which the public body may become a party pursuant to N.J.S.A. 10:4-12b(7)*


