**RESOLUTION IDENTIFYING SMALL  
CITIES FAIR HOUSING OFFICER**

**WHEREAS**, the Township of Downe is applying for a Fiscal Year 2022 Small Cities Community Development Block Grant application for \$200,000 from the NJ DCA Small Cities Program to provide rehabilitation loans to low and moderate income homeowners in Downe Township; and

**WHEREAS**, the Township of Downe must make efforts to affirmatively further fair housing; and

**WHEREAS**, the Township of Downe has reviewed various actions that would be acceptable to the New Jersey State Department of Community Affairs and the U.S. Department of Housing and Urban Development; and

**WHEREAS**, the Township of Downe has made assurances in the grant agreement that;

1. It will comply with the Housing and Community Development Act of 1974, as amended, and regulations issues thereto; and
2. It will comply with the Civil Rights Act of 1964, and the regulations issued thereto it; and
3. It will comply with the Fair Housing Act of 1968 and will affirmatively further fair housing; and
4. It will comply with the Age Discrimination Act of 1975 and with the Rehabilitation Act of 1973.

**NOW, THEREFORE, BE IT RESOLVED**, that the Municipal Clerk shall be designated as the Small Cities Program Fair Housing Officer for the Township of Downe; and


**BE IT FURTHER RESOLVED**, that the Fair Housing Officer shall contact the USHUD Regional Office of Housing and Equal Opportunity and the NJ Division on Civil Rights, inform those agencies of his/her appointment as Fair Housing Officer and request Fair Housing Information; and


**BE IT FURTHER RESOLVED**, that the Fair Housing Officer shall provide fair housing advisory services and assistance and referral advice to persons requesting such assistance from the Township of Downe; and

**BE IT FURTHER RESOLVED**, that the Township of Downe will publish in the local newspaper of record and post at the Township Municipal Building a public notice announcing the appointment of the Fair Housing Officer and the availability of local fair housing advisory services.
