**RESOLUTION TO AUTHORIZE CHANGE ORDER #2 FOR MOTT  
MACDONALD CONTRACT FOR THE FORTESCUE AND GANDY BEACH  
WASTEWATER COLLECTION, CONVEYANCE AND TREATMENT PROJECT**

**WHEREAS,** the Downe Township Committee has previously awarded a contract to Mott MacDonald, LLC for Professional Engineering Services for the Fortescue and Gandy Beach Communities Wastewater Collection, Conveyance and Treatment Project pursuant to Resolution R-81-2017 adopted July 10, 2017; and

**WHEREAS,** the change order in the amount of \$146,780.71 is necessary to cover the unforeseen changes to the original scope of work for the Design and Permitting Phase Services and as fully identified on the November 4, 2020 updated professional engineering services budget as submitted; and

**WHEREAS,** throughout the course of the project, Mott MacDonald has attempted to accommodate additional work within

the estimated budget. However, additional various unforeseen items have caused the previously approved budget to be exceeded. Change Order #2 in the amount of \$135,000.00 is necessary to cover the unforeseen changes to the original scope of work for the Design and Permitting Phase Services and the completion of the remaining work items.


