**RESOLUTION APPOINTING THOMAS J. TEDESCO,
PROFESSIONAL ENGINEER (PE) THE MUNICIPAL
ENGINEER FOR A ONE (1) YEAR TERM**

WHEREAS, there exists a need to employ and contract for professional services for the year 2022; and

WHEREAS, the Township Committee desires to employ and contract with Tedesco Engineering, LLC as "Municipal Engineer" for the purposes of carrying out the responsibilities of Municipal Engineer; and

WHEREAS, the Township shall pay the Municipal Engineer, Thomas J. Tedesco, Jr., PE, at the rate of \$122.00 an hour plus expenses for services rendered to Downe Township by the Municipal Engineer; and


WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.) requires that a Resolution authorizing the award of contracts for "Professional Services" without competitive bids and the contract be made available for public inspection:

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey, as follows:

1. The Downe Township Committee hereby authorizes the Mayor and Municipal Clerk to execute a form of Agreement with Thomas J. Tedesco, PE, of 182 Friesburg Road, Bridgeton, New Jersey 08302 beginning January 4, 2022 through the date of Reorganization 2023 as Municipal Engineer.
2. The contract is awarded without competitive bidding as a "Professional Service" in accordance with N.J.S.A. 40A:11-5(1)(a) of the Local Public Contracts Law because the services of the provider are specialized and qualitative in nature and such services cannot be reasonably described by written specification and extensive training and certification are required to satisfactorily provide such services pursuant to applicable New Jersey State Law.
3. A notice of this action shall be published one time in an official newspaper of the Township of Downe in accordance with N.J.S.A. 40A:11-5(1)(a)(i).
