**RESOLUTION AUTHORIZING PROFESSIONAL SERVICE AGREEMENT WITH
MOTT MACDONALD FOR ENGINEERING SERVICES FOR GANDY BEACH
BULKHEAD DAMAGE ON NORTH COVE ROAD**

WHEREAS, the Township of Downe is in need of professional services with respect to engineering work to design plans for the repair of the North Cove Road bulkhead at Gandy's Beach; and

WHEREAS, the Township of Downe received a proposal from Mott MacDonald to provide engineering design services to repair the damaged bulkhead on North Cove Road and to replace the bin block wall including all permit applications for approximately 763 linear feet along a portion of North Cove Road.

WHEREAS, such services are professional services by a recognized profession and are, therefore, exempt pursuant to the Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.); and

WHEREAS, the Township Committee of the Township of Downe is desirous of authorizing an agreement with Mott MacDonald to perform necessary engineering design services in accordance with the proposal attached hereto and made a part hereof; and


WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.) requires that the resolution authorizing the award of contracts for professional services without competitive bids, and the contract itself, must be available for public inspection;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Downe in the County of Cumberland, State of New Jersey, that the Mayor and Clerk are hereby authorized to enter into a professional services agreement with Mott MacDonald, 211 Bayberry Drive, Suite 1A, Cape May Court House, NJ 08210 as annexed hereto for the Gandy Beach Bulkhead damage.

BE IT FURTHER RESOLVED by the Township Committee of the Township of Downe that the foregoing is contingent upon a certification of available funds being on file.
