**RESOLUTION PROVIDING FOR THE INSERTION OF ITEMS OF REVENUE IN

(CHAPTER 159, P.L. 1048)  
CUMBERLAND COUNTY CULTURAL & HERITAGE GRANT**

**WHEREAS**, N.J.S.A 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item or revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget, and

**WHEREAS**, said Director may also approve the insertion of an item of appropriation for equal amount.

**NOW THEREFORE, BE IT RESOLVED** that the Township of Downe hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2022 in the sum of **\$4,230.00** which item is now available as a revenue from **Cumberland County Cultural & Heritage Grant** pursuant to the provisions of statute, and

**BE IT FURTHER RESOLVED** that a like sum of **\$4,230.00** be and the same is hereby appropriated under the caption of **Cumberland County Cultural & Heritage Grant**

**NOW THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Downe hereby authorizes such action and that two copies of this resolution be filed with the Division of Local Government Services, New Jersey Department of Community Affairs for approval.
