RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF DOWNE, CUMBERLAND COUNTY ADOPTING THE CUMBERLAND COUNTY MULTI-HAZARD MITIGATION PLAN UPDATE DOWNE TOWNSHIP, NEW JERSEY

WHEREAS, the Township Committee recognizes the threat that natural hazards pose to people and property within Downe Township; and

WHEREAS, the Township of Downe has participated in the preparation of the Cumberland County Multi-Hazard Mitigation Plan Update, a multi-jurisdictional, multi-hazard mitigation plan in accordance with the Disaster Mitigation Act of 2000; and

WHEREAS, the Cumberland County Multi-Hazard Mitigation Plan
Update includes:

- A Base Plan containing summary information common to all participating jurisdictions in Cumberland County, and
- The Downe Township Appendix that identifies mitigation goals, strategies, and measures specifically for the Township of Downe to reduce or eliminate long-term risk to people and property from the impacts of future hazard events and disasters; and

WHEREAS, adoption by the Township of Downe demonstrates commitment to hazard mitigation and achieving the goals outlined in the Cumberland County Multi-Hazard Mitigation Plan Update.

NOW, THREFORE, in accordance with the Township Committee of the Township of Downe, be it resolved by the Township of Downe, Cumberland County, New Jersey, that:

The Township Committee adopted the Cumberland County Multi-Hazard Mitigation Plan Update Base Plan and the Downe Township Appendix including authorizing the formation and duties of the Township of Downe Hazard Mitigation Working Group as follows:

- 1. The Working Group shall be convened by the Downe Township Emergency Management Coordinator and will include representatives of the following departments, agencies, and organizations and other interested parties:
 - a. Charles Lupton Downe Township OEM Coordinator
 - b. Kurt Silvers Downe Township Deputy OEM Coordinator
- 2. The Working Group shall convene to conduct plan implementation and maintenance activities as identified in the Base Plan and Downe Township Appendix including monitoring, evaluation, and updating the Downe Township Appendix, conducting outreach and education for residents and property owners, and providing annual reports regarding progress in implementing the identified mitigation measures to the Township Committee and the Cumberland County Office of Emergency Management
