**RESOLUTION AUTHORIZING APPLICATION FOR A NEW JERSEY  
HISTORICAL COMMISSION RE-GRANTING PROGRAM GRANT**

**WHEREAS**, the Cumberland County Cultural & Heritage Commission provides grants to municipal governments through its N.J. Historical Commission Re-Granting Program; and

**WHEREAS**, the Township of Downe desires to further the public interest by obtaining funds for State and Federal historic designation for Union Hall which is a Township-owned property;

**WHEREAS**, the purpose of the grant will be for historic preservation of Union Hall which received a Certificate of Eligibility in 1993;

**WHEREAS**, Union Hall was built during the turn of the 20<sup>th</sup> century at a time in the United States when social organizations played an essential role in towns like Dividing Creek; and

**WHEREAS**, Union Hall hosted its first meeting on June 24, 1897;

**WHEREAS**, the Township will use the NJHT's funds in accordance with such rules, regulations, and applicable statutes, and will enter into an agreement with the County for the above-named project;

**NOW, THEREFORE**, the governing body resolves that Michael Rothman or the successor to the office of Mayor is hereby authorized to:


- (a) Make application for such a grant,
- (b) Provide additional application information and furnish such documents as may be required, and
- (c) Act as the authorized correspondent of the for the Township of Downe; and

**NOW, THEREFORE, BE IT FURTHER RESOLVED BY** the governing body of the Township of Downe:

1. That the Mayor of the Township of Downe is hereby authorized to execute an agreement and any amendment thereto with the NJHT for the above-described project;
2. That the applicant agrees to comply with all applicable federal, state, and local laws, rules, and regulations in its performance of the project; and
3. That this resolution shall take effect immediately.
