**WHEREAS**, the Township of Downe is in need of consulting services for negotiations with Comcast regarding their renewal agreement; and

**WHEREAS**, the Township has identified Salmon Ventures Limited as an entity available to perform such services; and

**WHEREAS**, the Township Committee of the Township of Downe is desirous of authorizing an agreement with Salmon Ventures Limited (SVL), to perform necessary consulting services for the Comcast franchise renewal process in accordance with the proposal attached hereto and made a part hereof; and

**WHEREAS**, the contractor will supply all necessary documents to the Township prior to any work being performed, such as business registration certificate, EEOC certification, etc.; and


**WHEREAS**, this agreement shall not commence unless the funds are available and have been certified by the local finance officer; and
