## RESOLUTION OF THE TOWNSHIP OF DOWNE AUTHORIZING EXECUTION AND FILING OF SEWER LINE CONSERVATION RESTRICTIONS

WHEREAS, the Township of Downe has determined that it is in the best interests of its residents to do all work necessary for the construction and operation of a Sewer System within the Township; and

WHEREAS, Downe has obtained a CAFRA Permit, NJDEP Division of Land Resource Protection (DLRP) File No. 0604-18-0005.2 LUP 210001, pursuant to the Coastal Area Facilities Review Act, N.J.S.A. 13:19-1 and the Coastal Zone Management Rules, N.J.A.C. 7:7, for a land use development; and

WHEREAS, the Permit issued to Downe is conditioned upon Downe's recording, or causing the recording of a Grantee-approved Sewer Line Conservation Restriction ("SLCR") pursuant to N.J.A.C. 7:7-18 and N.J.A.C. 7:7-14.3 for the proposed sanitary sewer line authorized under the CAFRA Permit File No. 0604-18-0005.2 LUP 210001; and

WHEREAS, the Township of Downe believes it in the best interests of the Township to execute the Sewer Line Conservation Restriction easement for the benefit of the project.

NOW, THEREFORE, be it Resolved by the Township Committee that the Township of Downe that the Mayor and Clerk are hereby authorized to execute the Sewer Line Conservation Restriction easement and any associated documents necessary to effectuate the approvals necessary for this project.
