**AWARDING ASPHALT PAVING CORPORATION CONTRACT FOR
THE PAVING OF LOUISIANA, VASSAR, ADALINE, BAY AND
BUDNEY AVENUES**

WHEREAS, the Township of Downe was awarded funding in the amount of \$246,000.00 from the New Jersey Department of Transportation's (NJDOT) 2021 Municipal Aid Program for improvements to Louisiana, Vassar, Adaline, Bay and Budney Avenues located in Fortescue; and,

WHEREAS, Tedesco Engineering LLC, was contracted to prepare construction plans and specifications, prepare bidding documents, and conduct the bid opening.

WHEREAS, in accordance with the Local Public Contracts Law, bids were received on October 25, 2022 for the paving of Louisiana, Vassar, Adaline, Bay & Budney Avenues and Tedesco Engineering LLC, has provided a recommendation for award to perform the necessary road paving.

WHEREAS, Tedesco Engineering LLC, has determined that the lowest responsible bidder was Asphalt Paving Corporation, PO Box 310, 378 Elmwood Avenue, Malaga, NJ 08328 in the amount of \$181,122.00.


NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey as follows:

1. Subject to the concurrence of the Commissioner of the New Jersey Department of Transportation, Asphalt Paving Corporation is hereby awarded a contract in the amount of \$181,122.00 for the paving of Pennsylvania Avenue in accordance with the plans and specifications prepared by Tedesco Engineering LLC.
2. The Mayor and Clerk of the Township of Downe are hereby authorized to execute a contract with Asphalt Paving Corporation as set forth above.
3. A Certificate of Availability of Funds for this project has been approved by the Chief Financial Officer of the Township of Downe.
