A RESOLUTION OPPOSING THE DISCONTINUATION OF BUOYS IN THE UPPER MAURICE RIVER FROM MAURICE RIVER BUOY 17 (LLNR 1775) TO MAURICE RIVER BUOY 50 (LLNR 1943)

WHEREAS, the United States Coast Guard is proposing to discontinue the buoys in the Upper Maurice River from Maurice River Buoy 17 (LLNR 1775) to Maurice River Buoy 50 (LLNR 1943); and

WHEREAS, local mariners have provided that these 31 buoys are instrumental in the navigation of the Upper Maurice River; especially at night-time; and

WHEREAS, the Township Committee of Maurice River believes that removal of these buoys will present a case for vessels not being able to safely navigate the river at night or in unsatisfactory weather conditions.

NOW, THEREFORE, BE IT RESOLVED, that the Township Committee of Maurice River Township, in the County of Cumberland, and the State of New Jersey strongly opposes the removal of the 31 buoys located above the Mauricetown Bridge all the way to Millville (aka: from Maurice River Buoy 17 (LLNR 1775) to Maurice River Buoy 50 (LLNR 1943) as their removal would limit navigation of the Upper Maurice River.
