**RESOLUTION AUTHORIZING PROFESSIONAL SERVICE AGREEMENT
WITH MOTT MacDONALD FOR COASTAL ENGINEERING SERVICES**

WHEREAS, the Township of Downe is in need of professional services with respect to coastal engineering work to design plans for storm repairs and permitting for work regarding Tropical Storm Isaias (PW466 and PW480) as well as additional work as described; and

WHEREAS, the Township of Downe received a proposal from Mott MacDonald to provide engineering design services in support of storm repairs and permitting as described in their November 29, 2022 proposal, including a comprehensive Municipal Public Access Plan, an application to NJDEP-DLRP, surveying and preparation of construction drawings for the project; and

WHEREAS, such services are professional services by a recognized profession and are, therefore, exempt pursuant to the Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.); and

WHEREAS, the Township Committee of the Township of Downe is desirous of authorizing an agreement with Mott MacDonald to perform necessary engineering design work in accordance with the proposal attached hereto and made a part hereof; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.) requires that the resolution authorizing the award of contracts for professional services without competitive bids, and the contract itself, must be available for public inspection;


