RESOLUTION APPOINTING BOND COUNSEL

WHEREAS, there exists a need for the appointment of Bond Counsel for Downe Township; and

WHEREAS, the appointment of specialized Bond Counsel may be made without competitive bids as a "Professional Service" under the provisions of the Local Public Contracts Law pursuant to N.J.S.A. 40A:11-5(1)(a)(i); and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et. seq.) requires that the Resolution authorizing the award of contracts for "Professional Services" without competitive bids and the contract be made available for public inspection:


NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey, as follows:

1. Fleishman Daniels Law Office, LLC is hereby appointed as Bond Counsel for the Township of Downe for a period of one (1) year. The term is effective January 2, 2023 through Reorganization 2024; or the appointment or reappointment of Bond Counsel whichever occurs first.

2. The Downe Township Committee hereby authorizes the Mayor and Clerk to execute a form of Agreement with Fleishman Daniels Law Office, LLC of 646 Ocean Heights Avenue, Linwood, NJ 08221.
3. That this contract is awarded without competitive bidding as a "Professional Service" in accordance with N.J.S.A. 40A:11-5(1)(a)(i) of the Local Public Contracts Law because the services of the provider are specialized and qualitative in nature and such services cannot be reasonably described by written specification and extensive training and certification are required to satisfactorily provide such services pursuant to applicable New Jersey State Law.
4. A notice of this action shall be published one time in a official newspaper of the Township of Downe in accordance with N.J.S.A. 40A:115(1)(a)(i).
